This contract is between Doggy Doggy @ Kitshouse (DD@KH) and/or a representative of DD@KH and the Dog Owner/Client for this and all future dog boarding and/or daycare. The fee per dog for boarding is \$65 a day and daycare is \$40 a day. DD@KH and/or a representative of DD@KH agree to provide dog care services in a reliable, trustworthy, and caring manner.

DOG CARE

1. I authorize Doggy Doggy @ Kitshouse (DD@KH) and/or a representative of DD@KH to perform the services as described on the DD@KH web page (<https://www.doggydoggyatkitshouse.com>), which shall become part of this contract.
2. If my dog (s) becomes ill while in the care of DD@KH and/or a representative DD@KH, I authorize him/her to care for my dog(s) by transporting them to my veterinarian (or the nearest available vet) if he/she feels this is needed for the dog in his/her best judgment and I (Dog owner/client) am not reachable. I authorize DD@KH and/or a representative of DD@KH to approve any emergency treatment recommended by the veterinarian excluding euthanasia. I agree to pay DD@KH promptly for any charges incurred. I release DD@KH and/or a representative of DD@KH from all liabilities related to transportation, treatment, and expense.

LIABILITY

3. Dog owner/Client agrees to hold harmless DD@KH and/or a representative of DD@KH whether based upon negligence or otherwise.
4. It is expressly understood and agreed that DD@KH and/or a representative DD@KH shall not be held responsible for any damage to the dog owner/client's property, or that of others, caused by the dog(s) while under the care of DD@KH.
5. If the client's dog(s) bites or attacks anything (animal or person), DD@KH and or a representative of DD@KH reserves the right to refuse service and, when necessary, may relocate the dogs(s) to a safe place such as a kennel. Bites must be reported to the local authorities.
6. The owner will be liable for all medical care expenses and damages that result from their animal's bite.
7. DD@KH and/or a representative of DD@KH shall not be held liable for injury, disappearance, or death of the dog (s).
8. Dog(s) must be dropped off and picked up at DD@KH's home for boarding and daycare.
9. 24-hours-notice of a change or cancellation is required or the full fee is due to DD@KH.
10. The entire amount for boarding while the client is out of town is due to DD@KH before DD@KH and/or a representative of DD@KH begins boarding services and daycare.

If DD@KH determines the dog (s) needs veterinarian care, DD@KH will contact the dog owner/client (you) first, then the dog owner/client's veterinarian, or if neither is available, a reliable veterinarian. Both parties have read, understood, and agree with the contents of this contract.
